



## Message from the President Invitation to attend the 2021 Annual General Meeting

Dear Members,

On behalf of the Executive Committee of the Mona Vale Chamber of Commerce, I am pleased to invite you to participate in our **2021 Annual General Meeting**.

In response to the ongoing uncertainty and the potential health risks arising from COVID-19, our 2021 AGM will be held in accord with our COVID safe plan. This is designed to protect our members and our associates.

The AGM will be held at **6pm (AEDT) on Wednesday 15 December, 2021 at Bayview Anchorage Marina – Le Bayview Café, 1714 Pittwater Road, Bayview**. Members will be able to participate in our AGM by:

- voting on any resolution to be considered at the AGM can be done personally by a financial Member or by proxy on the prescribed form under the hand of the Member or of a subscribed Company under the common seal or by one of its directors authorised on that behalf by lodging the Proxy Form on the Chamber website (Contact us Mona Vale Chamber) on or before 12PM on 13 December, 2021 before the AGM; and
- asking questions of the Executive Committee: before the AGM, by lodging questions with our Chamber Secretary at <u>Feedback - Mona Vale Chamber</u> the online platform

At the meeting, there are four items of business:

## Item 1: Confirmation of Minutes of 2020 AGM

Members will be asked to confirm the minutes of the last annual general meeting.

## Item 2: Consideration of Financial Statements and Reports

The President's Report, Financial Statements and Treasurer's Report of the MVCC for the year ended 30 June 2021 will be presented at the meeting.

I will deliver my report as President at the meeting, a copy of which, along with the 2020/21 Annual



Review will be uploaded on Home - Mona Vale Chamber after the AGM.

While there is no requirement for a resolution on these items of business, members will be given a reasonable opportunity to ask questions about, or make comments on, the operations and management of the MVCC.

## Item 3: Election of office bearers

The current position of President, Secretary, Treasurer and Non-executive member will expire at the next AGM. The casual vacancy for the role of Secretary will expire at the next AGM. The Vice President position held by Sue Sparke is not due to expire until the 2022 AGM.

incumbent office holder(s) - The current Treasurer has advised that he does not intend to nominate for a position and the current Non-Executive members term expires at the upcoming AGM.

Financial Members only may nominate, endorse nominations or vote on the business of the Chamber and any nominations must be submitted on the Chamber Website by the nominated time and date. Members with strong leadership and accredited capabilities are encouraged to put forward nominations on the prescribed form suitably seconded, being willing and committed to contribute with initiative and as called upon for the effective Executive Management of our important Community based Chamber. As the current President I put myself forward for re-election as President. There is no indication of intention for any of the other current Executive Committee Member as incumbent office holders.

There are 4-8 elected office bearer vacancies available to be filled. Following the election at the AGM, at the first Executive Management meeting, officer-holder positions will be voted upon for appointment, namely President, Secretary, Treasurer and one or more (up to 5 positions) for Non-Executive Committee office bearers.

Executive Committee Members positions will be selected from nominations received by a simple majority of votes by the elected Executive Committee Members. There being no other nominations for any office bearer position(s), the Executive Committee will declare registered nominations duly reelected and successfully elected nominations for contested positions duly elected at the first subsequent Executive Committee meeting.

I look forward to working with a new Executive Committee, for whatever role the Members may decide and hope that a strong capability will come forward to contribute and help lead our Chamber. I am committed to implementing our strategies, programs and planning as member benefits in the next term to improve the resilience and dynamic of the Local Business Community. I also thank each of the incumbent Executive and the former President, Secretary and other Executive Members for their contributions over the recent difficult time and wish each well for future Business success.
